3 2. Respondent is the holder of License No. 3246 issued by the Board for the practice
4 of osteopathic medicine in the State of Arizona.

5 **FINDING OF FACT**

6 3. Respondent did not respond to multiple Board subpoenas and lacked
7 communication with the Board.

8 **CONCLUSION OF LAW**

9 4. The conduct described in paragraph 3, above, is a violation of unprofessional
10 conduct pursuant to A.R.S. § 32-1854 (29), which states "Failing to allow properly authorized
11 board personnel to have, on presentation of a subpoena, access to any documents, reports of
12 records that are maintained by the physician and that relate to the physician's medical practice or
13 medically related activities pursuant to section 32-1855.01."

14 **ORDER**

15 5. Pursuant to the authority vested in the Board, **IT IS HEREBY ORDERED** that
16 Lynn Sweet, D.O., Holder of osteopathic medical License number 3314, is issued a **CIVIL**
17 **PENALTY OF \$250** pursuant to A.R.S. § 32-1855 (I).

You have the right to request a rehearing or review of this matter pursuant to A.R.S. § 41-1092.09. The request for rehearing or review must be filed with the Arizona Board of

1 Osteopathic Examiners within thirty (30) days. If you request a review or rehearing, you must
2 base your request on at least one of the eight grounds for review or rehearing that are allowed
3 under A.A.C. R4-22-106(D). Failure to file a motion for rehearing or review within 30 days has
4 the effect of prohibiting you from seeking judicial review of the Board's decision in the AZ
5 Courts.
