B. <u>Current Board Policy on Confidential Substance Abuse Rehabilitation Program and Non-Confidential</u> <u>Substance Abuse Rehabilitation Program and Proposed Revisions to the Policy</u>

Mr. Bohall provided a summary of the draft policy to the committee. The Committee discussed allowing all individuals to initially eligible to enter the Board's Confidential Program. Ms. Galvin suggested that an evaluation always be obtained when there is allegations of substance use. Develop parameters with 3rd party (Memo of Understanding) on 3 strikes. Dr. Walker clarified the levels of strikes and the outlined the terms of a strike.

Dr. Erbstoesser directed staff to make the recommended changes to the policy, to review the Arizona Dental Board's policy and bring the changes back to the committee at the January Board meeting.

C. Effects of Arizona Proposition 207 (Smart and Safe Act) to the Confidential Substance Abuse Rehabilitation Program and Probationary Monitoring Program

Mr. Bohall provided a summary of the draft policy to the committee. Ms. Galvin recommended that the policy define impairment and recommended there be a roll out period for the policy. Dr. Erbstoesser affirmed that he believes that the Board should treat cannabis the same as alcohol. Dr. Walker inquired if this policy would mirror the Board policy on physician's use of prescribed controlled substances at work.

Dr. Erbstoesser directed staff to make the recommended changes to the policy and bring the changes back to the committee at the next meeting.
