**3. CALL TO THE PUBLIC**

Dr. Cunningham recited the Board’s mission statement.

- A. Dr. Cunningham welcomed the Medical Students from Arizona College of Osteopathic Medicine at Midwestern University.
- B. Dr. Cunningham conducted the call to the public. No public comment was received.

**5. REVIEW, DISCUSSION, AND ACTION ON CASE REVIEWS OF ALLEGATIONS OF UNPROFESSIONAL CONDUCT A.R.S. § 32-1855 (D).**

A.Elizabeth Ann Ottney, DO DO-18-0072A License No. 4208

The Respondent was present and represented by attorney Scott Holden.

Respondent stated that she provided a full explanation to both the patient and her daughter regarding the treatment plan. She further stated that she explained that a patient would be admitted into the hospital for overnight observation when a bed was made available. The Respondent stated that care had been turned over to another physician.

The Board noted that there appeared to be no discharge paperwork for the patient only an Against Medical Advice Form.

Respondent stated that she believes the only way the patient would have been discharged if the nurse on staff would have provided AMA paperwork and did not discharge the patient correctly.

The Board expressed concern that there appeared to be a lack of communication either to the patient or to the nursing staff.

Respondent stated that she believes she provided adequate information to the patient but believes the communication issue occurred between her and the nursing staff and then between the nurse and the patient.

After discussion and consideration, the Board determined there was no statutory violation.

The complaint alleged that Respondent engaged conduct that could be considered a Boundary Violation, withheld patient records and failed to provide treatment to patient KT. Patient KT was present before the Board was sworn in by the court reporter.

Mr. Fradkin provided an opening statement to the Board.

Patient KT provided a statement to the Board. KT explained the details of his complaint and expressed concern over the treatment provided by the Respondent. KT provided a timeline of his treatment. KT stated that he had a sexual relationship with the Respondent prior to receiving treatment.

The Respondent confirmed that he had a relationship with patient KT prior to treatment. The Respondent provided testimony regarding patient KT and the care provided.

The Board then received testimony from the patient in case number DO-18-0138A.
